Prime Minister Narendra Modi's bilateral engagements with Iranian President Masoud Pezeshkian and Russian President Vladimir Putin on the sidelines of the Shanghai Cooperation Organisation (SCO) Summit in Bishkek highlight India's commitment to **strategic autonomy** and **multi-alignment**. Amid escalating regional instabilities—from conflicts in West Asia affecting energy security and maritime transit to the ongoing Black Sea crisis impacting global supply chains—India's diplomatic position emphasizes dialogue, peace, and the protection of global commons.

PM calls for 'end of war' at meeting with Putin

The two leaders discuss conflicts in West Asia and Black Sea region, impact on maritime trade and safety of Indian seafarers; Putin highlights positive trends in Moscow-New Delhi economic ties

Prime Minister Narendra Modi on Monday met Russian President Vladimir Putin on the sidelines of the SCO summit in Bishkek and said the world "must move from endless war to end of war for the benefit of humanity".

The External Affairs Ministry said the two leaders discussed conflicts in West Asia and in the Black Sea region, where, in recent months, Indian seafarers have been attacked by both Russian and Ukrainian forces.

"Had extensive discussions with President Putin. Discussed the full range of the India-Russia Special and Privileged Strategic Partnership. It is gladdening to see significant progress across various sectors in recent years. Focus areas for India-Russia friendship remain energy, innovation, space, fertilisers, and people-to-people linkages," said Prime Minister Modi.

In a statement, the External Affairs Ministry said,

"They also shared perspectives on key regional and global issues of mutual interest, including the conflicts in West Asia and the Black Sea region which have impacted maritime trade and the safety and security of Indian seafarers. Prime Minister reiterated that dialogue and diplomacy was the way forward in

resolving conflicts." The upcoming BRICS summit featured prominently in the discussion, and Mr. Modi said he "looks forward to welcoming President Putin in India for the 18th BRICS summit on 12-13 September".

80th anniversary of ties The Bishkek meeting between Mr. Modi and Mr. Putin featured in talks during External Affairs Minister S. Jaishankar's visit to the Kremlin on August 24, when Mr. Putin had indicated that he would meet Prime Minister Modi in

Kyrgyzstan and also at the BRICS summit in Delhi.

"This time, our meeting is taking place on the eve of the Shanghai Cooperation Organisation Summit - an organisation that works to deepen contacts among the countries of the Global South and East, promotes the region's socioeconomic and cultural development, and contributes to building a just multipolar world," said President Putin in his remarks, reminding that next year will mark the 80th anniversary of establishment of diplomatic relations between New Delhi and Moscow.

Mr. Putin noted that the number of Indian students in Russia has increased almost seven-fold in a decade, and currently 40,000 Indians are studying in Russia.

President Putin said trade and economic cooperation between Russia and India is showing positive trends, with trade turnover increasing by more than 2%. He noted the growth in tourist exchange between the two countries, with a 16% increase in 2025.

Ensure peace, freedom of navigation, PM urges Iran

Modi meets Iran President on sidelines of SCO summit, calls for stability in West Asia; Pezeshkian requests India to use its 'extensive contacts' to help with the dialogue process, blames U.S. for war

In the first top-level meeting between Iran and India since the beginning of the war on Iran in February, Prime Minister Narendra Modi on Monday met Iranian President Masoud Pezeshkian in Kyrgyzstan's Bishkek and urged him to ensure peace and stability in West Asia and freedom of navigation in the Strait of Hormuz.

Mr. Pezeshkian blamed Israel and the U.S. for the conflict and requested Mr. Modi to "use India's extensive contacts with various parties" and help the dialogue process.

After the meeting that took place on the sidelines of the SCO summit, Mr. Modi said on X, "Reiterated our commitment to strengthening India's long-standing friendship with Iran across diverse sectors. We want to expand and diversify our trade basket in the times to come. We had

a discussion on the prevailing situation in the region. India will continue to support all efforts aimed at ensuring lasting peace." The Ministry of External Affairs said Mr. Modi called for freedom of navigation and commerce.

"Civilians and civilian infrastructure, including commercial shipping and seafarers must not be harmed under any circumstances," he said.

Mr. Modi said he looked

forward to welcoming Mr. Pezeshkian to India for the upcoming BRICS summit.

President Pezeshkian said his country had a "responsibility" to defend the Iranian people "from danger and insecurity and to create conditions necessary for them to achieve peace, tranquillity and security". He said Iran was "focused on ensuring peace and security and resolving issues through dialogue and negotiations."

Mr. Pezeshkian blamed Israel and the U.S. for creating "restrictions and obstacles" before Iran and said that "Despite the pressures and restrictions being imposed in an attempt to obstruct Iran's relations with other countries, Tehran is ready to expand its cooperation with India."

He referred to the talks with the U.S. on a ceasefire and said, "The Islamic Republic of Iran has remained committed to the obligations it has undertaken within the framework of the agreements, but unfortunately, the American side has failed to fulfil its commitments."

In June, Mr. Pezeshkian had invited Mr. Modi to the funeral of the slain Supreme Leader Ali Khamenei that was held in July. India was represented by a team that included the Governor of Bihar Lt. Gen. Syed Ata Hasnain (retd.).

India's categorical rejection of the Permanent Court of Arbitration's (PCA) ruling at The Hague regarding the Indus Waters Treaty (IWT) underlines a major shift in New Delhi's approach to cross-border water sharing and national security. Following the April 2025 Pahalgam terror attack, India placed the 1960 treaty in abeyance, asserting that state-sponsored terrorism and international treaty obligations cannot coexist seamlessly. India's assertion of non-jurisdiction highlights the friction between international arbitration mechanisms and national sovereign rights during security crises.

India rejects Hague court's Indus Waters Treaty ruling, says it has no jurisdiction

Hours after the Permanent Court of Arbitration at The Hague said the Indus Waters Treaty remains "fully in force" and called on India to "observe its obligations", the External Affairs Ministry rejected this, saying that the "very establishment of this alleged arbitral body" was a "grave violation" of the treaty.

"This so-called Court was constituted by the World Bank in patent breach of the terms of the Treaty, and India categorically rejects its so-called award," the Ministry said on Monday.

It went on to say that India had "never recognised the existence in law of this illegally-constituted and so-called Court of Arbitration, and has consistently maintained that the very establishment of this alleged arbitral body constitutes a grave violation of the Indus Waters Treaty".

"Accordingly, India has never appeared before this body and has refused to take any cognisance of its earlier pronouncements," the Ministry said.

India had placed the In-



India had placed the treaty in abeyance following the Pahalgam terror attack.

Indus Waters Treaty "in abeyance" following the Pahalgam terror attack on April 22, 2025, and the Ministry, in its response on Monday, reiterated its position. "India's decision to hold the Indus Waters Treaty in abeyance remains in force," it said.

The Ministry also said that "this so-called Court of Arbitration has no jurisdiction whatsoever to pronounce on India's sovereign decisions".

It added that the court's pronouncements, "now or in the future, will have no effect on India's actions in connection with the projects being undertaken by India".

Earlier, the arbitration body, considering Pakis-

tan's plea, examined the reasons under which India placed the treaty "in abeyance" and said that "none of these grounds could justify suspension or termination of the Treaty".

Issuing an "award" on the 'Status of the Indus Waters Treaty and Order on Interim Measures concerning the Ratle Hydro-Electric Plant (RHEP)', the Permanent Court of Arbitration said, "Accordingly, the Indus Waters Treaty remains fully in force, and India must observe its obligations under the Treaty, including those relating to the design and operation of its hydro-electric projects on the Western Rivers."

It had also considered Pakistan's plea on imposing measures on India regarding the RHEP, saying, "In a unanimous decision, the Court decided to impose measures prohibiting India from concreting the RHEP dam wall and power intake structure above certain levels until 90 days after the Neutral Expert's final decision, which is expected in July 2027."

The Court of Arbitration is chaired by Prof. Sean D. Murphy of the U.S.

Recent studies, including research published in the *Journal of Threatened Taxa*, emphasize that electrocution risks posed by medium- and high-voltage transmission lines could drive local raptor populations to extinction. Protecting these apex scavengers requires combining infrastructure retrofits with smarter spatial planning for carcass disposal.

Deadly span

India's power infrastructure is emerging as a big threat to vultures

Whereas for many decades the chief concern about vulture safety was centered on chemical threats, the threat of electrocution posed by India's expanding power infrastructure may supersede it. In the 1990s, India's vultures suffered one of the world's worst population crashes, nosediving 99.5% by 2007 from a high of around four crore in the 1980s; the white-rumped, Indian, and slender-billed vultures were nearly wiped out. The culprit was diclofenac, a painkiller for cattle that wrecks vulture kidneys. The government banned the use of diclofenac, with additional bans in 2023 to mitigate threats posed by aceclofenac and ketoprofen, among some other NSAIDs. The birds' decline left carcasses exposed for longer, supporting feral dog populations and leading to rabies outbreaks; a 2024 study in *American Economic Review* estimated that human mortality thus rose 4% and the associated damages cost India \$69.4 billion a year. While electrocution has not become as deadly as NSAIDs have been, the fragility of the vulture population and the proliferation of unsafe power infrastructure warrant early action. One official survey reported in 2025 that vultures were nesting at only 50% of their historic nesting sites. It is no trivial detail that the raptors' wide wingspans mean a large individual can contact two conductors at once. They also have a habit of perching on elevated structures, are attracted to open landscapes, and have incentives to congregate where the availability of food is predictable, a risk enhanced by people dumping food waste around electrical installations.

As *The Hindu* reported based on a recent study in the *Journal of Threatened Taxa*, "relocating a livestock carcass dump 2.4 km away from high-tension power infrastructure near Uttarakhand's Dehradun may have saved these large scavengers from ... electrocution". An assessment prepared for the State Climate Resilient Power System Development Project also noted an Egyptian vulture and some steppe eagles had been electrocuted on medium-voltage, rather than high-voltage, lines. Research has noted that persistent mortality due to electrocution alone could render a local population extinct. Avian electrocution is also likely under-documented in India since dead birds can be removed by humans or scavenged. As the study indicated, one inexpensive solution is to separate vulture feeding sites from power infrastructure. Other measures to protect raptors, and even other birds, especially near settlements, include insulating conductors, increasing the gap between energised and grounded components or otherwise preventing a bird from bridging them – non-trivial considering vulture wingspans – and installing safe perches.

- **Article 21 & Precedents:** Judicial expansion in cases like *Olga Tellis* (1985) linked the right to livelihood directly with the right to life. Furthermore, Sanjit Roy (1983) established that paying wages below minimum wage thresholds constitutes forced labor under **Article 23**.
- **Doctrine of Non-Retrogression:** Applied in *Navtej Singh Johar* (2018), this doctrine mandates that once a state expands social rights through progressive legislation, it cannot enact policy rollbacks that dilute those realized rights.

The broken promise of right to work

The replacement of MGNREGA with the VB-GRAM G Act has weakened the rural right-to-work framework, restoring a meaningful right to work through adequate funding, living wages and stronger local institutions would advance constitutional aims while also supporting rural demand and economic growth

On August 21, a three-judge Supreme Court Bench led by the Chief Justice of India dismissed a petition and sought a fresh one in a case on minimum wages in rural employment guarantee programmes. The Bench lauded MGNREGA's role in rural development. It probed whether the 'Right to Work' should be treated on par with Article 21, the fundamental right to life, sparking an important discussion on the constitutional foundations of this right.

A guarantee under strain

Despite its limited scope of only 100 days of work per rural household and chronic underfunding, the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) was the only law anchored in the core principle of the right to work. In December 2025, the Union Government replaced MGNREGA with the Viksit Bharat — Guarantee for Rozgar & Aajeevika Mission (Gramin) (VB-GRAM G) Act, and its implementation began on July 1. About 3.44 crore households worked for about 44 crore person-days under MGNREGA in July and August, on average, over the previous five years (Table B). There has been a 68% decrease in employment in July and August this year compared with the average of the preceding five years. Notwithstanding the proverbial 'teething issues', the dismantling of MGNREGA's demand-driven right-to-work framework and the disproportionate fiscal burden that the new law places on States are likely to be major factors behind the dramatic fall in employment under the VB-GRAM G Act.

The impact of taking away even this limited right to work is therefore palpable. Discussions around the recent Supreme Court observations on the right to work can be traced back to the Constituent Assembly debates. While most members agreed that a right to work was vital, the debate centred on whether it should be a fundamental right or part of the Directive Principles of State Policy (DPSP). The DPSPs do not automatically constitute rights but are meant to serve as precepts for governments to formulate laws and policies. This became the basis of the differences in perspective.

Professor K.T. Shah had strongly advocated recognising the right to work as a fundamental right, arguing that the State needed a constitutional and positive legal mandate to guarantee socio-economic security to its citizens. Dr. B.R. Ambedkar, among others, held that while the right to work was an essential goal, to immediately universal enforcement was not fiscally and institutionally viable in a newly independent India that had been hollowed out of its resources. The placement of the right within the Directive Principles, rather than among the fundamental rights, thus reflected a deliberate constitutionalism of aspiration, rather than an abandonment of the welfare ideal. As scholars Ajayit Kapoor and Manu Bhargava have written in their essay 'Ambedkar and the anti-isolation of Fellowship', "The constitution does not establish the nation, but rather provides the tools to help achieve it."

Therefore, Article 41 of the DPSP states: "The State shall, within the limits of its economic capacity and development,

THE GIST

From aspiration to a statutory right

The Supreme Court, in *Olga Tellis vs Bombay Municipal Corporation* (1985), ruled that the right to livelihood was a necessary condition for the fundamental right to life, giving a judicial fillip to the right to work. Spurred by the collective efforts of activists and rural workers, the National Rural Employment Guarantee Act was passed in 2005. Although limited in scope, it made a pan India right to work law a reality for the first time. The State had to ensure its statutory obligation to provide employment at minimum wages.

In 2006, MGNREGA wages were delinked from the Minimum Wages Act, 1948. Over time, MGNREGA wages barely kept pace with inflation and continued to remain lower than the minimum agricultural wages in most States. Low wages and an inadequate budget for generating employment have resulted in a steep decline in household earnings, with estimated total household earnings halving in July and August this year compared with the same months last year (Figure 1).

During the recent hearing, the Supreme Court Bench remarked that if financial resources remained the same, having a minimum wage threshold could reduce the number of workers who could be provided employment. This remark, which appears to align with the Union government's approach to employment guarantee, merits scrutiny on at least two counts.

First, it vitates the judgment in *Sanjit Roy vs State of Rajasthan* (1983) where the Supreme Court observed that payment of wages below minimum wages violates Article 23 of the Constitution and is akin to forced labour. Second, it rests on a misleading economic logic that financial resources must remain unchanged and constrained.

In reality, higher wages for rural workers increase their purchasing power, enhance their freedom, and improve human development outcomes. These, in turn, increase effective demand for goods and services, creating a positive multiplier effect, resulting in higher economic productivity. Therefore, higher government spending on an employment guarantee programme at increased wages can yield a mutually reinforcing cycle between development and growth.

A retreat from the right to work

By putting an arbitrary cap on funds for the VB-GRAM G Act and not linking it with minimum wages, the very notion of employment guarantee stands delegitimised. States are already grappling with fiscal constraints and curtailed borrowing limits under the Fiscal Responsibility and Budget Management (FRBM) framework. The increased burden of funding the VB-GRAM G Act will prevent States from generating employment. The sharp drop in employment and earnings is a reflection of this change.

The VB-GRAM G Act also contains provisions to demarcate certain areas and exclude them from the scheme, thereby limiting the universality of MGNREGA's right to work.

Lawyer Parthiban Chakraborty highlights how the Supreme Court has affirmed the doctrine of non-retrogression in *Navtej Singh Johar vs Union of India*. The doctrine implies that once the State has achieved a certain level of progressive legislation and enforceability of a right, it cannot implement measures that deliberately undo it. Non-retrogression operates as a check on State power, ensuring that rights, once realised, are not diluted later. The replacement of MGNREGA with the VB-GRAM G Act appears to be in violation of this doctrine.

Rural wages have been stagnant for a decade, while women are increasingly employed as 'unpaid family workers'. In such light, the minimal requirements for affording the commitment to the right to work are linking MGNREGA wages to living wages, timely payment of wages, a focus on social audits by empowering local institutions to be partners in mitigating corruption, and giving more powers to Panchayat Raj institutions. All these measures could be implemented within a legal framework of the right to work. The VB-GRAM G Act, unfortunately, is silent on most of them. Reinstating the right to work would therefore not only be a legal course correction advancing constitutional aims, but would also be sound economics. The Baltic Way — Gandhi's imprint on Baltic freedom

August 23, 2026, marked the 37th anniversary of the Baltic Way, the historic 1989 human chain that became a watershed moment in the Gandhian-inspired Singing Revolution in Lithuania, Latvia, and Estonia, culminating in the restoration of Baltic independence in 1990-91. Conversations across the Baltic states revealed powerful personal reflections on the Baltic Way and Gandhian non-violence: "We studied India's freedom struggle and chose Gandhian non-violent resistance to reclaim our national freedom from Soviet rule." "We watched the film *Gandhi* on Lithuanian national television, telecast for 24 hours." "It was thrilling to join a non-violent protest against the Soviet army at Vilnius Cathedral Square; even as a bullet passed near my ear, I stood firm." "Baltic Way matters a lot for us today."

A turning point

The Singing Revolution (1986-91), shaped by songs and non-violence during Mikhail Gorbachev's perestroika and glasnost, reached a turning point with the Baltic Way, when two million people formed a 675-kilometre human chain from Tallinn through Riga to Vilnius, demanding freedom from Soviet rule. It remains a powerful symbol of unity, solidarity, and freedom. The Baltic Way was organised on the 50th anniversary of the 1939 Molotov-Ribbentrop Pact to expose its secret protocol, which divided Eastern Europe into German and Soviet spheres of influence, and paved the way for the Soviet annexation of the Baltic states in 1940. Having gained independence in 1918, the Baltics lost it after 22 years. The Baltic Way exposed Soviet-era repression, leading to the Soviet Union's acknowledgement of the secret protocol's existence and the Baltic states' re-independence in 1991. Its global media coverage drew international attention, while its inscription in

UNESCO's Memory of the World Register and Guinness World Records recognition reinforced its international legacy.

An enduring influence

Gandhi's ideas travelled globally, inspiring movements from the American civil rights struggle to South Africa and beyond. Today, the Baltic Way reflects the enduring relevance of his principles of non-violence, truth, and human dignity, while echoing the non-cooperation and civil disobedience of his 1930 Dandi March.

Gandhi showed that moral authority could outweigh military power through ahimsa, satyagraha, civil resistance, mass mobilisation, and the principle that a nation's rule depends on people's consent and cooperation. The Baltic Way and the Singing Revolution stand as a testimony to the success of people's power and civilian-based defence drawn from the Gandhi-led Indian freedom movement.

The Singing Revolution's leaders drew on global traditions of non-violent resistance. Latvian scholar Maija Küle noted that, lacking local theorists, they turned to Gandhi and Martin Luther King Jr.; Latvia's earlier cultural links with India may also have encouraged this attraction to Gandhian ideas. Lithuania, too, played a key role in developing non-violent civilian-based defence inspired by Gandhi.

In a 2012 conversation with this writer, the late Prof. Gražina Miniotaitė, a leading ideologue of Lithuania's Singing Revolution, recalled that non-violence was widely understood from the outset as essential. The December 1990 "Republic in Danger" declaration urged adherence to "non-violence and non-cooperation with the occupational authorities".

Unlike other thinkers of non-violence, Miniotaitė regarded Gandhi as the most successful in both theory and practice, demonstrating that non-violent struggle could

effectively resist foreign rule. Richard Attenborough's 1982 film *Gandhi* was broadcast on Lithuanian national television to educate citizens about non-violent resistance. Confronting Soviet troops, people repeated: "We won't fight," "We follow Gandhi," and "We are peaceful people."

Building closer ties

Since 1992, the Baltic states have drawn on Gandhian and cultural ties to deepen relations with India, expanding cooperation in technology, sustainability, the blue economy, and culture. The Government of India's Ministry of Commerce and Industry estimates show that India's total bilateral trade with Lithuania reached \$490.61 million; with Latvia, \$475.66 million, and with Estonia, \$219.69 million in 2025-26.

Baltic political discourse reflects Gandhian influence through Gandhi's Lithuanian-born Litvak "soulmate" Hermann Kallenbach; Vydušas's engagement with Gandhian thought; Antanas Poška's meetings with Gandhi; Sonja Schlesin's secretaryship; and Estonian translations of Gandhi by Linnart Hall. These ties continue through annual commemorations of the 2015 Gandhi-Kallenbach monument in Kallenbach's birthplace, Rusnė, most recently in July 2026; the Kallenbach Memorial Lectures; and the India-Lithuania Friendship Award (this year, it honoured the people of Goa during the 400th anniversary of missionary Andrius Rudamina). India has also gifted Gandhi memorials to the Baltics, including a bust unveiled in Latvia in 2019 and a statue installed in Estonia in 2025.

The Baltic Way endures as a chain of freedom and ideas, linking courage with conscience. Its contemporary significance is multifaceted: a model of non-violent resistance, a site of contested memory, a narrative in Russia-West tensions, and ultimately, a tribute to Gandhi and India.
